# **Eastern Public School Student Council Constitution**

## **First Amendment 2025**

*(As amended by the Student Council Meeting with the Senior School Leadership Team)*

*A*

*BILL*

*To amend the EPS SC Constitution*

*Be it enacted by the SC Constitution Amendment Committee as follows:-*

### **1. Amendment to Article 1: Purpose of the SC- 1A**

1A i. Maintaining Discipline- Student Council members are responsible for maintaining discipline in the classes, during lunch breaks and events. SC members should take the **lead** in maintaining the discipline. The SC members hold the **authority** to issue a **yellow card** to the students who are not abiding by the **School's Vision and Mission**, after the approval from the respective Coordinator.

1 A ii. A bridge between the student body and management/staff/leadership to organise and conduct school events.

1 A iii. Grooming future leaders- allocating responsibilities to students in various fields.

1 A iv. Changing the culture of EPS- Student Council should develop the culture of hand-holding the juniors. Providing support to their juniors. Hand-holding and mentoring juniors during a physical, emotional, mental and academic challenge.

1 A v. Selfless service to the school community.

### **2. Amendment to Article 6: Elections- 6A**

6A.I Code of Conduct for Elections

- a. All candidates and participants in the election process are expected to uphold the core values of **respect, humility, and justice** throughout their campaigns.
- b. Respectful Campaigning

- i. Campaigns must focus on candidates' proposed policies, initiatives, leadership qualities, and vision for their respective positions.
    - ii. Personal attacks, name-calling, defamation, character assassination, or targeting individuals on the basis of personal identity, history, attributes, or affiliations are strictly prohibited.
    - iii. Candidates must not use inflammatory remarks or derogatory language in any form—verbal, written, or digital.
  - c. Violations of the Code may lead to:
    - i. Formal warning from the Election Commissioner
    - ii. Disqualification from the election as determined by the Election Commission
    - iii. Further disciplinary action by school authorities if necessary

**6A.II** Enforcing the Code of Conduct for Elections outlined in 6.1 and addressing violations of the same.

### **3. Amendment to Article 7: Disqualification of Student Council Member(s) 7A**

7A. Failure to follow the Code of Conduct for Elections outlined in 6.1

### **4. Amendment to Article 10 Subsidiaries- 10A**

10A Class Representatives may access video recordings from their classroom camera as outlined in Section 11.4

### **5. Insertion of new Article 11. Empowerment of SC**

11.1 Infrastructure Issues

- a. The Student Council may identify and report issues related to classroom furniture, washroom conditions, infrastructure, and IT systems, including but not limited to damage, malfunction, or lack of maintenance
- b. All concerns must be reported using the form prescribed in Annexure III
- c. Once a report is submitted:

- i. The School Captain is responsible for initiating and overseeing the necessary action within one week of submission.
- ii. Subject to the School Captain's approval, a Student Council member may escalate the issue to the relevant administrative authority
- iii. The time between the issue being acknowledged and resolved must not exceed one week, unless deemed otherwise by the School Captain.
- iv. If an issue remains unresolved beyond the timeframe specified in 11.1.c.iii, it may be escalated to the Principal with the School Captain's approval.

#### 11.2 Recommendation for Salary Deductions

- a. In cases of repeated negligence or failure to fulfil duties by the staff, the Student Council may recommend a salary deduction
- b. Such a recommendation must be supported with clear documentation and evidence, and submitted formally to a Principal by the School Captain
- c. The Principals hold the authority to act on the recommendation at their discretion.

#### 11.3 Canteen Oversight

- a. The Student Council may recommend penalties for the school canteen in cases of hygiene concerns, service delays, or violations of basic operational standards.
- b. Such recommendations must be supported with relevant observations or documented evidence, and submitted formally to the Principal and the head of the Canteen Committee.
- c. The Principals hold the authority to act on the recommendation at their discretion. If a recommendation is rejected, a reason must be provided to the Student Council.

#### 11.4 Access to Class Recordings

- a. Class Representatives may access class video recordings during lunch breaks
- b. Approval is not required, but the email request must copy the Class Teacher and Coordinator
- c. Access is limited to a maximum of three times per month per Class, tracked by the Coordinator
